




The Global Health Exhibition team would like to thank you for attending the live in-person conferences. Future of Preventive Health has been awarded 6 CME hours.

- The SCFHS is a Saudi Arabian scientific commission that regulates health-care related practices and accreditation at all levels in Saudi Arabia.

- To be eligible to claim credits, a minimum of 70% attendance is required.
